## Liability Release Form

I have asked to participate in the Saturday July 16, 2016 **Hike To Paint Workshop** provided and led by BRUCE KATLIN/BRUCE KATLIN CREATES. I understand that participation in these activities is not without risk.

### ACKNOWLEDGEMENT OF RISK, WAIVER, RELEASE AND INDEMNIFICATION

WHILE BRUCE KATLIN/BRUCE KATLIN CREATES MAKE EVERY EFFORT TO PROVIDE A SAFE AND PLEASANT ENVIRONMENT FOR PARTICIPANTS, WE DO REQUIRE THAT THIS PARTICIPATION AGREEMENT BE READ, COMPLETED, SIGNED AND DATED BY EACH PARTICIPANT, OR BY THE PARENT OR LEGAL GUARDIAN OF EACH CHILD UNDER 18 YEARS OF AGE, WHO WISHES TO PARTICIPATE IN THE PAINT TO HIKE WORKSHOP. CHILDREN 12 TO 17 YEARS OF AGE MUST BE ACCOMPANIED BY A PARENT OR GUARDIAN 21 YEARS OF AGE OR OLDER. NO CHILDREN UNDER THE AGE OF TWELVE WILL BE ADMITTED TO THIS WORKSHOP.

**BRUCE KATLIN/BRUCE KATLIN CREATES** has taken reasonable steps to provide equipment workshop participants with information regarding hiking in high altitude wilderness areas so that they can participate in activities for which they may not have experience with. However, these activities are not without risk. Certain risks cannot be eliminated due to the setting and without destroying the unique character of these activities. The same elements that contribute to the character of these activities can be cause of loss and damage to your property, accidental injury or illness or, in extreme cases, permanent trauma or death. We want you to be informed of the inherent risks and dangerous from high altitude exercise and believe that it is important for you to be informed and know in advance about inherent risks.

I understand that no activity program is absolutely free of risk. I, on behalf of myself and my family, including minor children, agree to assume full responsibility. I expressly assume all risk and responsibility involving accidents sustained while participating in the "Hike To Paint Workshop" resulting from negligence on my part, that of my family or employees, officers, directors or agents of BRUCE KATLIN/BRUCE KATLIN CREATES.

I affirm that I am fully capable of participating in this activity and that my general health is good, that I do not have any condition that might endanger the life or health of myself or others participating in any activity. I affirm that I know of no reason why I should not participate.

I understand the signature of the parent or guardian of a minor child on this document shall make all provisions of this release and assumption of the risk agreement applicable to and binding on the minor child. I agree that New Mexico law shall govern this release.

I, on behalf of myself, my children, my assigns and my estate, agree to release and hold harmless BRUCE KATLIN/BRUCE KATLIN CREATES, its agents and/or employees for any and all claims for injuries, causes of action, or liability related to participation in any BRUCE KATLIN/BRUCE KATLIN CREATES activity.

Should BRUCE KATLIN/BRUCE KATLIN CREATES or anyone acting on his behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold BRUCE KATLIN/BRUCE KATLIN CREATES harmless for all such fees and costs.

By signing this document, I acknowledge that if anyone is hurt or property damaged during my or my minor child's participation in these activities, I and/or my minor child may be found by a court of law to have waived any right to maintain a lawsuit against BRUCE KATLIN/BRUCE KATLIN CREATES on the basis of any claim which has been released herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and agree to be bound by its terms.

This liability release shall be legally binding upon heirs, my assigns, legal guardians, personal representations and myself. I have carefully read this agreement and understand its contents. I am aware that I am releasing certain rights that I otherwise may have, and I enter into this agreement on behalf of myself, minor children, and/or wards, of my own free will.
